

Dial-A-Ride

School Rider Policy

The following MUST be completed and returned to Dial-A-Ride before any child/minor under the age of 18 is able to ride the Dial-A-Ride bus without a parent or guardian present.

It shall be the responsibility of each child/minor using the Dial-A-Ride Bus to:

1. Remain seated in the seat assigned by the bus driver at ALL times while riding the bus.
2. Respect and listen to the Dial-A-Ride driver and follow their instructions.
3. Refrain from using inappropriate language.
4. Be prepared to board the bus at the scheduled pick up time with your fare ready.
5. Remain seated until the bus comes to a complete stop.
6. Enter and leave the bus only at the front door except in the case of an emergency.
7. Keep your head and hands inside of the bus at all times and keep your hands to yourself.
8. Maintain a reasonable noise level in the bus.
9. Report any damage to the bus as soon as it is observed.
10. Keep the inside of the bus clean.
11. Wear footwear at all times.
12. Be courteous to others.
13. Refrain from bullying or harassing others.

Failure to follow these policies could result in a loss of Dial-A-Ride transportation privileges.

Parents will be contacted if there is a violation of the policy.

A violation slip will also be sent home with the child.

1. The first violation will result in a warning.
2. The second instance of a violation will result in a one day suspension.
3. The third instance of a violation will result in an extended suspension at the supervisor's discretion.

Violations of a serious nature, including but not limited to bullying, violence, harassment, etc. may result in an immediate and extended suspension at the supervisor's discretion.

Children Must Provide Fare When Boarding the Bus

If a child boards the bus without proper fare they will receive a violation. Once a child has received three violations for failing to provide proper fare, service will be suspended. Before service can be reinstated the child's parent/guardian must come into the Dial-A-Ride office to pay all past due fares and meet with the Dial-A-Ride supervisor.
