

Indian Street/Buttles Street Crashes



The following document details crash data along the Indian Street and Buttles Street Corridor (Business US 10) from January 1, 2019 to September 1, 2021.

- Crashes highlighted in **yellow** are property damage crashes, where no injury was reported
- Crashes highlighted in **green** are hit and run crashes
- Crashes highlighted in **red** are personal injury crashes. Injuries range from possible injury to suspected serious injury
- No fatalities were reported

The data obtained shows crashes on Indian Street, Buttles Street and all intersecting roadways starting from Loons Road to Jerome Street. Each roadway was individually searched as primary roadways where the crash occurred.
